The Board of Trustees of the Village of Stickney met in regular session on Tuesday, August 21, 2012 at 7:00 p.m. in the Stickney Village Hall, 6533 W. Pershing Road, Stickney, Illinois.

**Upon the roll call, the following Trustees were present:
Trustees present Horne, Morelli, Savopoulos, Walik, White and Zeedyk.**

Trustee Zeedyk moved, duly seconded by Trustee Horne, to approve the minutes of the previous regular meeting on Tuesday, September 4, 2012.

President O'Reilly declared the motion carried.**

Trustee Walik moved, duly seconded by Trustee White that the bills, approved by the various committees of the Board, be approved for payment, and to approve warrants which authorize the Village Treasurer to draw checks to pay the bills, to be signed by the authorized signers, as provided for by the Ordinances of the Village of Stickney.

CLERKS REPORT: A reminder was given about the Stickney Fire Department's Child Car Seat Safety event on September 22, 2012. She also questioned the Fire Chief about the safety aspect of a safety seat being used in the back seat area of a pick-up truck with a jump seat.

Trustee Horne informed us that he spoke to the general contractor doing the streets on Kenilworth and 41st Place. They will be starting to lower the manholes and soft cut the streets on Thursday. Also, the paving contractor from NiCor will be working all week on the sidewalks on Harlem Avenue. Trustee Horne said he was working with Trustee Walik doing a punch list with NiCor and the landscaping. They then report to their finding to the NiCor office. Some of the places they are not thrilled with. As time goes by he said, "We'll see what happens".

Trustee Zeedyk gave the report from the Stickney Police Department for the month of July.

DEPARTMENT REPORTS:

Fire Chief Larry Meyer reported that the fire department will be doing a trenching exercise in the south end of the cemetery. On next Saturday from 10:00 to 4:00 they will be conducting their child safety seat event. They will be having technicians coming from various agencies such as the State Police and some other towns. They will check the installation, they will check on line if there are any recalls on the car seat or the mounts. The people conducting this event have to take a 32-hour course to become certified to do this. The chief suggested that people promote this event with people who may have just bought a car seat.
